1. Mountain View Pet Resort ("Mountain View") utilizes daycare and boarding play groups where dogs interact with other dogs. In the course of such interaction and play, your pet may suffer minor injuries from time to time such as but not limited to nicks, cuts, and scrapes. You release Mountain View from any liability for such injuries.

2. If your pet is to aggressively inflict injury to another pet, Owner accepts responsibility of the veterinary expenses to the injured pet. INITIAL _____

3. I hereby grant Mountain View permission to act on my behalf, and in my pets best interest, by obtaining veterinary care at my expense, if deemed necessary, for illness or injury. I further agree to pay for all vet and other necessary services incurred by and for my pet. The Mountain View staff, in its sole discretion, reserves the Right to (A) Treat such injuries on site, or (B) have the pet seen by a vet if it is deemed that such injury requires vet Care. We also will contact you as soon as possible but we will not hold up care at any time. INITIAL _____

4. Mountain View shall exercise due diligence and responsible care for the pet delivered by the owner to us. All pets are handled, or cared for by Mountain View staff without liability on Mountain View's part for loss or damage from disease, theft, fire, death, escape, injury, or harm to persons or other pets. INITIAL _____

5. You specifically represent to Mountain View that, to your knowledge, your pet is in good health and has not been exposed to any contagious diseases (ie: kennel cough, upper respiratory infection, GI upset, etc.) within a thirty day period prior to check in. You are aware that by dropping your pet off at Mountain View there is a risk that your pet may contract kennel cough, upper respiratory illness, GI upset or other viruses. You understand that this is not due to any circumstances or conditions at Mountain View and agree not to hold Mountain View liable in the event that your pet becomes ill during or after his/her stay. INITIAL _____

6. You further agree to provide Mountain View proof of the three required vaccinations (Rabies, Distemper, Bordatella) upon request prior to entry to Mountain View Pet Resort. INITIAL _____

7. Mountain View, in its sole discretion, may remove dog(s) for any behavior we see unfit or unsafe from the playgroup and may not permit dog(s) to interact further with other dogs during the current or subsequent stays. Mountain View may use tools (ie: water bottle, etc.) to assist with altering the dogs behavior should a dog become aggressive/start fighting. INITIAL _____

8. Owner agrees to be financially responsible for damages caused to property/facility by your pet. INITIAL _____

9. Owner agrees to pay the set daily rate for boarding or daycare and futher agrees that if the pet is not picked up by 6pm, they will be charged a late fee of \$5.00 for every occurrence. Owner further agrees that the pet will not leave the facility until all charges are paid. INITIAL _____

10. Owner understands that any animal left for ten days beyond the agreed day of pick-up may be sold or disposed of at the discretion of the kennel owner. The owner specifically waives all statutory or legal rights to the contrary.

11. You certify the accuracy of all information provided to Mountain View in writing or orally about the pet by signing this agreement. Mountain View reserves the right to deny admittance to any pet for any reason at any time, including but not limited to injury, sickness, or behavior that, in the sole judgement of Mountain View could jeopardize the health or safety of other pets or the staff of Mountain View. INITIAL _____

This agreement contains the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, administrators, personal representatives and assigns of the owner and Mountain View Pet Resort.
